### Kansas Historic Sites Board of Review January 18, 1992 10:00 a.m. Kansas Museum of History

Vice-Chairman Sara Ullmann called the meeting to order at 10:00 a.m. Other board members present were Tom Barr, R.S. Delamater, Dave DeBusman, Jean McKenna, Judith Major, Ramon Powers, and Tom Witty. Board members J. Eric Engstrom and Mary Maley were out of the country. Historic Preservation Department staff members present were Dick Pankratz, Sandra McDaniel, Barbara Anderson, Martha Hagedorn-Krass, Larry Jochims, Vance Kelley, and Carl Magnuson. Persons representing several properties on the agenda were also present.

Vice-Chairman Ullmann welcomed new board member Dave DeBusman who replaced Dennis Jacobs whose term had expired.

A motion to approve the minutes of the October 19, 1991 meeting was made by Judith Major, seconded by Ramon Powers, and carried.

Vance Kelley presented an explanation of the tax incentives program. Slides were shown of three tax incentives projects--the (Old) Osage Hotel in Arkansas City, the Central Motor and Finance Company in Topeka, and the Benedict House in Lawrence.

Barbara Anderson reported on the eleven Heritage Trust Fund projects that were funded for fiscal year 1992. Project agreements for four of the eleven are completed. A workshop was held on January 17 for prospective applicants for the spring round of planning grants. The deadline for those applications is March 12.

Jeanne McKenna presented the recommendations of the Grants Review Committee that had met on December 6, 1991 to review applications for federal Historic Preservation Funds for fiscal year 1992. Federal allocation for fiscal year 1992 was \$296,479. Ten per cent of that amount is reserved for CLG cities. The committee's recommendations for funding are as follows:

Kansas State Historical Society, Inc., \$4,900 City of Hutchinson, CLG, \$15,000 City of Wichita, CLG, \$14,520 Johnson County Museum System, \$15,655 Mo-Kan Regional Council, \$11,906 University of Kansas Museum of Anthropology, \$39,982 Finney County Historical Society, up to \$15,574

A motion was made by R. S. Delamater to accept the recommendation of the committee, Judith Major seconded the motion and it carried.

Martha Hagedorn-Krass presented eight properties for nomination to the National Register or State Register. All nominations were approved with the exception of the Bixby House which was tabled.

# REPORT OF THE GRANTS REVIEW COMMITTEE TO THE KANSAS HISTORIC SITES BOARD OF REVIEW, JANUARY 18, 1992

The grants review committee, which was composed of J. Eric Engstrom, R. S. Delamater, and Jeanne McKenna, met with staff on December 6, 1991, to review and discuss the eligible applications received for the federal fiscal year 1992 Historic Preservation Fund grants. The eligible survey and planning grant applications were as follows:

City of Hutchinson, CLG, \$15,000, development of third grade historic preservation curriculum;

City of Wichita, CLG, \$14,520, Fairmount Survey, Friends II Survey, Old Town design guidelines, and College Hill analysis;

Finney County Historical Society, \$15,754, reconnaissance survey of Garden City;

Johnson County Museum System, \$15,655, Phase II of Johnson County survey;

Kansas State Historical Society, Inc., \$4,900, newsletter publication project;

Linda Laird, \$7,900, grain elevator reconnaissance survey;

Mo-Kan Regional Council, \$11,906, survey of Old Atchison;

University of Kansas Museum of Anthropology, \$39,982, sand prairies geoarcheological survey in central and southwestern Kansas;

University of Nebraska-Omaha, \$13,680, archeological survey and evaluations in portions of the Cimarron, Arkansas, and Pawnee river basins in southwestern Kansas;

Wichita State University, \$6,571, reconnaissance survey of Lehigh Township in Marion County.

Staff advised the committee that the federal allocation for Kansas for FY 1992 was \$296,579. Of that amount \$29,658 must be reserved for CLGs; approximately \$85,000 to \$87,000 would be available for other grants.

In its review of the ten survey and planning grant applications, the committee employed an evaluation system developed by staff and used in prior years.

The committee did not use the evaluation system on the application submitted by Kansas State Historical Society, Inc. It was noted that this application was for the publication of the <u>Kansas Preservation</u> newsletter and that the printing was handled as a grant project through the private Society in order to facilitate its publication. The committee identified this as a "must fund" project and placed it at the top of the list. (A similar recommendation was made by last year's committee for the FY 91 grants.)

The committee discussed the two CLG applications (Hutchinson and Wichita), and after determining that both met all the requirements for funding, it recommended without ranking them that both be fully funded. Together the two requests totaled \$29,520--less than the 10% required CLG setaside of \$29,658. The committee requested staff to work with the applicants to determine the most productive use for the additional CLG funds that are available.

The committee evaluated the non-CLG projects, assigned points to them, and ranked them as follows:

Johnson County Museum System
Mo-Kan Regional Council
University of Kansas Museum of Anthropology
Finney County Historical Society
Wichita State University
Linda Laird
University of Nebraska-Omaha

With the amount of federal funds presently available, the committee recommended the following projects be funded:

Kansas State Historical Society, Inc., \$4,900 City of Hutchinson, CLG, \$15,000 City of Wichita, CLG, \$14,520 Johnson County Museum System, \$15,655 Mo-Kan Regional Council, \$11,906 University of Kansas Museum of Anthropology, \$39,982 Finney County Historical Society, up to \$15,574

The committee made the following observations about some of the projects that were not funded. The application from the University of Nebraska-Omaha (UNO) responded to the same staff-established priority as did the University of Kansas Museum of Anthropology (KU). In the evaluation process it was determined that overall the KU application was more responsive to the stated priority than was that of UNO. The application submitted by Linda Laird was of interest to the committee because of the resources this project would target; however, it was not recommended for funding because of the very high hourly wages budgeted by the applicant (\$38.00/hour), a rate more than double average project wages. The Wichita State University application did not grade well; it was weak in the areas of public education and planning and the quality of products from past projects has been inconsistent.

# Kansas Historic Sites Board of Review May 2, 1992 10:00 a.m. Preston Hale Room--Ward-Meade House, Topeka

Chairman J. Eric Engstrom called the meeting to order at 10:00 a.m. Other board members present were Tom Barr, Dave DeBusman, R.S. Delamater, Jean McKenna, Judith Major, Mary Maley, Ramon Powers, Sara Ullmann, and Tom Witty. Historic Preservation Department staff members present were Dick Pankratz, Sandy McDaniel, Barbara Anderson, Desmond Anyanwu, Martha Hagedorn-Krass, Larry Jochims, Vance Kelley, Carl Magnuson, and Martin Stein. Members of the public interested in properties being presented to the board were also present.

Chairman Engstrom asked board members and HPD staff to identify themselves to the public.

A motion to approve the minutes of the January 18, 1992, board meeting was made by R.S. Delamater, seconded by Sara Ullmann, and carried.

Ramon Powers informed the board on legislative activity concerning the society's new building. Ramon and Dick Pankratz attended the National Conference of State Historic Preservation Officers in Washington, D.C. at which Ramon was elected to the board for a three-year term.

Dick summarized some of the HPD activities since the last meeting. National Register property listings for Kansas now total 603. Those that have been added to the register include the John Mack Bridge in Wichita, the Benedict House in Lawrence, and the designation of Monroe School in Topeka as part of a National Historic Landmark listing with the Sumner School. Martha Hagedorn-Krass will attend a National Park Service planning workshop in the fall. Ramon and Dick will be meeting with personnel from the Advisory Council, the National Park Service, and the Tulsa Corps of Engineers in Halstead on May 5 concerning the local flood control project and its effects on the Warkentin Homestead in Harvey County.

Martin Stein gave the board a brief history of the Quindaro Townsite. The Historical Society is monitoring the site and letters have been sent to the city of Kansas City, KS and the AME church asking what their plans are concerning the site. Two concerns the Historical Society has are (1) to preserve the site and, (2) influence disposition of the artifacts from the site so that they may provide information about the history of Kansas. Tom Witty announced that the Kansas Anthropological Association's annual dig this year will be held at the Sharp's Creek Site at Lindsborg from May 30 to June 14. The KAA dig is in its eighteenth year.

Chairman Engstrom presented plaques to former board members Sister Monica Schneider and Jim Forsythe for their service to the board. Sister Monica had served on the board for ten years and Jim had served for eleven years. A luncheon to honor them will be held after the board meeting at the Steak and Ale restaurant.

A subcommittee report on the Heritage Trust Fund planning grants for 1992 was given by Mary Maley. The committee consisted of Mary Maley, Jeanne McKenna, and Eric Engstrom. Twenty applications were evaluated with five recommended for funding. They were as follows:

Gold Dust Hotel, Fredonia, \$6,800 Irvin Hall, Highland Community College, Highland, \$28,000 Soldiers and Sailors Memorial Building, Kansas City, \$37,852 Warkentin House, Newton, \$5,200 Watkins National Bank, Lawrence, \$7,200

Mary moved to adopt the recommendations of the committee, Jeanne McKenna seconded and it carried.

A subcommittee report on the Governor's Awards for Historic Preservation was given by Sara Ullmann. The committee consisted of Marc Lahr, Jeanne McKenna, and Sara Ullmann. The committee evaluated thirteen nominees and selected four to receive awards. They are as follows:

Joan Adam, for her leadership in the enactment of the Heritage Trust Fund law.

Kansas Anthropological Association, for promoting the preservation and conservation of the state's archeological resources.

Lawrence Preservation Alliance, for neighborhood conservation, community service and education.

Save the John Mack Bridge Committee, for community service and education for its successful effort to retain the John Mack Bridge, the largest Marsh Arch bridge built in Kansas.

R. S. Delamater moved to adopt the recommendation of the committee, Judith Major seconded and it carried. The award ceremony will be held on Monday, May 11, at 10:00 a.m. in the Governor's office. A reception will follow in the lobby of the Center for Historical Research.

Martha Hagedorn-Krass presented seven properties for nomination to the State Register or National Register. All nominations were approved by the board and the vote was unanimous unless otherwise noted.

### Kansas Historic Sites Board of Review August 21-22, 1992 9:00 a.m. Reno County Historical Society, Hutchinson

Chairman J. Eric Engstrom called the meeting to order at 9:00 a.m. Other board members present were Dave DeBusman, R.S. Delamater, David Haury (Ramon Powers' designee), Jeanne McKenna, Judith Major, Mary Maley, Sara Ullmann, and Tom Witty. Tom Barr is recuperating from major surgery and was not able to attend. Staff members present were Dick Pankratz, Sandy McDaniel, Desmond Anyanwu, Larry Jochims, and Martha Hagedorn-Krass. Members of the public interested in properties being presented to the board were also present.

Chairman Engstrom asked board members and staff to identify themselves to the public.

A motion to approve the minutes of the May 2, 1992, board meeting was made by Judith Major, seconded by Sara Ullmann, and carried.

The election of officers was next on the agenda. Officers for the past year were J. Eric Engstrom, chairman, and Sara Ullmann, vice-chair. Tom Witty moved to re-elect the present officers; Mary Maley seconded, and it carried.

Dick Pankratz gave an update on program activities since the May meeting. Ten more properties had been added to the National Register for a total of 613 listings. Those properties were: Glick-Orr House, Atchison; Wall-Ratzlaff House, Buhler; Harris-Borman House, Keebler-Stone House, Walt Mason House, and Warren Finney House, all in Emporia; WPA Beach House, Gardner Lake, Gardner vicinity; Vermilya-Boener House, and Lawrence vicinity; Giles-Nellis House and Chester B. Woodward House, Topeka. All of the Heritage Trust Fund projects that were awarded grants in the first round have either had construction work performed or have architects working on plans and specifications. A Heritage Trust Fund planning grant workshop was held on June 30. Those who attended were instructed in the procedures and requirements of the program. Tom Witty presented an illustrated report on the annual Kansas Archeology Training Program, which was held in McPherson County last June. Larry Jochims presented a slide show on Historic Contexts.

Martha Hagedorn-Krass presented nominations to the board for consideration for the state or national register. Those nominations and their dispositions are given below. Unless noted otherwise, the decisions were unanimous.

NOTE--In the board's discussion of this proposed nomination, a number of concerns were raised by different individuals. The fact that the building had been relocated to a completely different site and was oriented in a different direction from its original setting was an issue to some. There was also a concern whether the Department of Corrections had been advised of the proposed nomination and whether it was aware of the requirements that would be placed on DOC under the state's historic preservation law regarding review of projects within five hundred feet of the depot. It was noted by staff that no written criteria exist for evaluating relocated buildings for state register nomination. (Such criteria do exist for the National Register nominations.) It was noted that the current board had not previously been asked to consider a relocated property for the state register. Board members expressed reservations about establishing precedents without having written criteria. Another question that was raised dealt with the lack of verifiable information about the number of depots in the state that are still extant. For the reasons just enumerated the board voted not to approve the Lansing Depot at this time.

The date of the next meeting will be either November 7 or November 14. Staff will send postcards for board members to identify their preference.

Chairman Engstrom was authorized to appoint a committee from the board to work with staff on evaluation of applications for federal Historic Preservation Fund grants for survey and planning.

Jeanne McKenna proposed a resolution from the board to the Hutchinson Landmarks Commission and the Friends of Preservation expressing appreciation for hosting a reception for the board and staff. Eric Engstrom seconded the resolution and it carried.

Mary Maley proposed a resolution from the board to the Reno County Historical Society expressing appreciation for allowing the board and staff the use of their facility for the August meeting. Eric Engstrom seconded the resolution and it carried.

Tom Witty proposed a resolution from the board to Dr. and Mrs. James Casey expressing appreciation for their hospitality and use of their home at the reception held for the board and staff. Eric Engstrom seconded the resolution and it carried.

Dave DeBusman proposed a resolution from the board to Linda Laird, Assistant City Planner for the City of Hutchinson, thanking her for her role in making arrangements for the tours and reception enjoyed by the board and staff. Eric Engstrom seconded and it carried.

# Kansas Historic Sites Board of Review November 7, 1992 9:30 a.m. Kansas Museum of History--Topeka

Chairman J. Eric Engstrom called the meeting to order at 9:30 a.m. Other board members present were Tom Barr, Dave DeBusman, R. S. Delamater, David Haury as Ramon Powers' designee, Jeanne McKenna, Sara Ullmann, Tom Witty, and Cooper Woodring. Board member Judith Major was absent. Historic Preservation Office staff members present were Dick Pankratz, Sandy McDaniel, Barbara Anderson, Desmond Anyanwu, Martha Hagedorn-Krass, Larry Jochims, Vance Kelley, Carl Magnuson, and Martin Stein. Members of the public interested in properties being considered by the board were also present.

Chairman Engstrom welcomed back board member Tom Barr after an extended illness, and also welcomed new board member Cooper C. Woodring. HPD staff and board members were asked to identify themselves to the public.

A motion to approve the minutes of the August 21-22, 1992 board meeting was made by R.S. Delamater, seconded by Dave DeBusman, and carried.

Dick Pankratz gave an update on program activities since the August meeting. Two properties have been added to the National Register: the Abilene Union Pacific Depot in Dickinson County and the Booth Archeological Site in Jackson County. The National Register of Historic Places now has a total of 617 Kansas properties listed.

Larry Jochims presented an update on the progress of federal fiscal year 1991 and 1992 survey subgrants. Carl Magnuson brought the board up to date on the status of the Heritage Trust Fund (HTF) grant projects. Two projects have been completed since the August board meeting: the Big John Farm Limestone Bank Barn in Council Grove, and the Condon Bank in Coffeyville. One of the grant projects, the Santa Fe Depot in Madison, has received construction bids much higher than originally anticipated. If all proposed work were to be done on the depot, the amount of the project would be doubled. The cost of stabilization was found to be about \$61,735 rather than the \$42,500 originally projected. The additional monies for the project could be funded by the Heritage Trust Fund from the grant turned down by the Plevna General Store. Since the board originally gave approval of HTF grant monies for these projects, a motion to grant an additional \$16,000 for the depot project would be acceptable. Eric Engstrom moved that the board allocate the \$16,000 from HTF monies for the Santa Fe Depot project in Madison with the cautionary note that this is a highly unusual action and that it should not be considered as a precedent. It was seconded by Jeanne McKenna and carried.

The federal allocation to Kansas for FFY 1993 is \$290,270, a reduction of \$6,300 from last year. The National Park Service altered the way they applied the distribution formula. Ramon Powers was in New Orleans to attend the quarterly meeting of the board of directors of the National Council of State Historic Preservation Officers. Funding and the formula used to distribute the funds will be on the agenda.

Dr. Rolfe Mandel presented a slide program on buried ancient soils and archeological sites.

A public hearing on applications for federal Historic Preservation Funds for federal fiscal year 1993 was held on November 6 in the auditorium of the Center for Historic Research.

Subsequently a grants review committee, which was composed of Eric Engstrom and Dave DeBusman, was convened to evaluate applications. Approximately \$84,000 to \$89,000 will be available. Of that amount a minimum of \$29,027 must be reserved for Certified Local Governments. That would leave \$55,000 to \$59,000 available for other grants.

Dave DeBusman presented the committee report which recommended the following projects for funding:

Johnson County Museum System, Johnson Co. Historic Preservation Survey III, \$16,000

Kansas State Historical Society, Legal Study, \$5,000

Kansas State Historical Society, Newsletter Publication Project, \$5,500

This was an especially competitive year in there was less federal money allocated to our state for grants, but there was no shortage of high quality applications. The committee assigned scores to the applications based upon an evaluation system developed for this round of grants.

The committee first evaluated the CLG applications as a group and ranked them according to their satisfaction of program objectives. The applications were ranked in the following order:

# UPDATE ON GRANTS HISTORIC SITES BD. REVIEW NOVEMBER

WICHITA CLG FFY 91. We had prepared 600 reco forms for the first phase of West Wichita. The area c roughly Charles street on the west, the river on the e the north and Kellogg on the south.

We also had 865 reconnaissance forms prepared for wholeown III. This area is 16th street on the west to 21st on the east, the river on the north and St.Francis on the south.

We also funded the printing of an historic sites brochure (pass around)

WICHITA STATE UNIVERSITY FFY 91. We engaged them to survey Menno township of Marion county. We intended 325 structures but found that there were fewer structures in the township.

EMPORIA STATE UNIVERSITY FFY 91. Our initial intent was to complete a comprehensive survey of 80 to 100 structures within farm and ranch complexes in Middle Creek and Diamond Creek watersheds as well as 500 Reconnaissance forms. this covered approximately 171,520 acres including the villages of Burdick and Delavan. The Original comprehensive portion of the grant was amended to completion of a National Register Nomination of the Whitney Ranch.

LAWRENCE CLG FFY 91. Our intent was to complete the resurvey and rewrite the statement of significance for the Old West Lawrence Historic District. The result has been somewhat less than what was originally intended and we will need to do additional work to reach our initial goal.

JOHNSON COUNTY FFY 91. We stared the survey of the area around Roeland Park and Merriam with the intent of receiving 800 survey forms and a master plan for the completion of the survey of

all of Johnson county. We have received the master plan and over 1050 forms.

**PEABODY** FFY 91. We conducted a comprehensive survey of downtown Peabody and the project produced a 320 page history of the downtown buildings.

KANSAS CITY KANSAS CLG FFY 91. We received 104 survey forms and a project report containing a context statement of buildings designed by Kansas City Architects Rose and Peterson.

MO-KAN FFY 91. We continued the rural reconnaissance survey of 2 townships in Atchison county and received 650 forms.

**FINNEY COUNTY** FFY 92. We are currently in the process of surveying at a reconnaissance level, 800 properties in the city of Garden City.

**HUTCHINSON CLG** FFY 92. We have had prepared a 3 rd grade educational curriculum that will be used in the Hutchinson school system this year. We hope other Kansas communities will be able to adapt it to their own use.

**JOHNSON COUNTY** FFY 92. We are currently in the process of preparing 800 reconnaissance forms in the area of Gardner, Spring Hill, Desoto, Aubry, and Stilwell.

WICHITA CLG FFY 93. We are conducting reconnaissance survey in two areas of Wichita.

Friends II which covers the area from Douglas along McLean to Atchison and east along the Arkansas to the starting point on Douglas. (915)

Fairmont which covers the area west along 17th from Vassar to Hillside, south to the south side of 12th, east to the east side of

Vassar and north to 17th street. (300)

Design Guidelines are also being prepared for East Douglas and they are conducting analysis of the College Hill Historic area to determine logical boundaries for a district designation.
